MINUTES: Motion by Dave Culp to accept the Cabinet Meeting Minutes of January 24, 2015 with correction Doug Ricci was not

present, 2<sup>nd</sup> by Doug Ricci, motion carried.

## TREASURER'S REPORT - Jim Henry reporting

Financial report: Jim noted there was no significant change since January 24<sup>th</sup> meeting regarding YTD finances. Discussion this day centered on unrestricted cabinet designated funds. Jim explained these are funds not donor given but funds set aside by Cabinets over the years to cover expense "in case" there would be expense in a specific area (i.e. General Synod Delegates the year the Synod was supposed to gather in Hawaii). These accounts have been kept on the books over the years even though the specific events have passed. In reviewing the list, specifically four funds that appeared as unrestricted were discussed and moved to the donor temporarily restricted list —those being, Discretionary Fund, Retired Clergy Luncheon Fund, Ministerial Aid Fund and Student-In-Care Emergency Fund. *Motion by Becky Sunday to adjust net assets to properly reflect the unrestricted, cabinet designated funds for 2014, 2<sup>nd</sup> by Becky Erb Strang, motion carried. A 2<sup>nd</sup> motion by Becky Sunday to undesignate all remaining unrestricted cabinet designated funds, except the Sabbatical Leave Fund, 2<sup>nd</sup> by Becky Erb Strang, motion carried.* 

Budget Report: Discussion centered on the drop in OCWM giving over the past many years. At the present time we have a retention rate of 57-43%. The question was asked as to what other Association retention rates were and it is believed they are 55-45 at Western, but they have an endowment fund as a resource; 40-60 by Eastern; Sonka is 25-70 and Central Southeast is 27-73. By comparison Sonka and Central Southeast are about the same size as Northwest. The Conference retention rate is 65-35. Based on the 2014 OCWM year-end giving total of 346,521., the 2015 OCWM giving budget has been reduced to 350,000 (from 377,400) changing the bottom line to deficit 13,644 for year-end and that is with an increased retention rate of 60/40 which is still unknown at this time. Jim stated Northwest is at bear bones as far as reducing expenditures any further – leaving salary adjustments open for the 2016 budget. *Motion by Dave Culp to recommend the revised final 2015 budget as printed, 2<sup>nd</sup> by Dave Jones, motion carried with two abstentions. Motion by Becky Sunday to accept the 2016 goal budget with adjustments of OCWM to 350,000 and salary adjustments as appropriate, 2<sup>nd</sup> by Jim Henry, motion carried.*
